

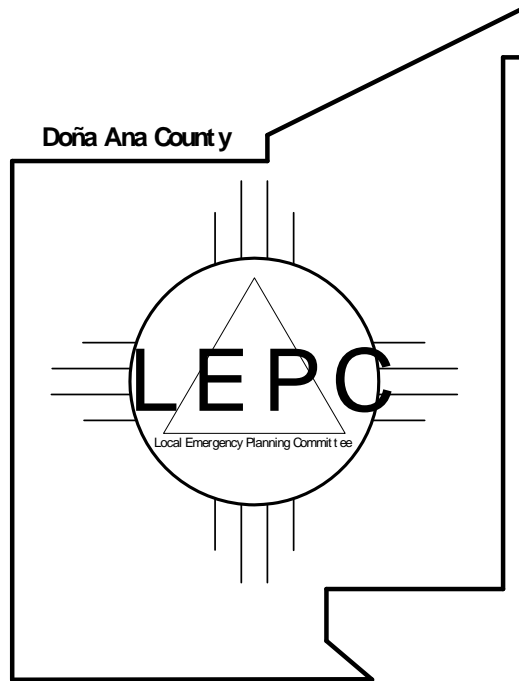

What is the Doña Ana County - City of Las Cruces Local Emergency Planning Committee (LEPC)?

The Doña Ana County – City of Las Cruces LEPC (DAC-CLC LEPC) was established to meet the requirements of the Federal Emergency Planning and Community Right-to-Know Act, also known as the Superfund Amendment and Reauthorization Act.

The main purpose of an LEPC is to plan emergency responses and protect the community from the potential impact of natural or technological hazards and related disasters.

The DAC - CLC LEPC is comprised of dedicated volunteers from city, county and state governments; local industries and organizations; medical facilities; educational systems; emergency response personnel and concerned citizens.
